Dog exercise area is ONLY in the coral to the NW of the Building. It is stocked for waste removal. DO NOT exercise dogs against the building, grass area under the trees, or anywhere else. Please do not exercise them elsewhere in the neighbourhood.

Do not leave dogs in the vehicle if they are noisy.

Notice to all

The Lower Mainland Dog Fanciers of B.C. wish to caution all exhibitors and attendees that these trials are held in compliance with the Provincial and Local Health rules. **Protocols for all visitors on the venue will wear a mask that covers the nose and mouth. Social Distancing will be followed in so far as feasible.**

Each judge, trial superintendent and trial chairperson has flexibility in making sure the policies are adhered to, and timing of events is at their discretion. Some exhibitors may feel that we are too strict and other may share the opposite reaction that we are not strict enough. We are hoping to err on the side of safety without interfering in the spirit of the competitions.

The building limit for public events will be adhered to, and exhibitors will be requested to return to their vehicle and/or depart when their exercises are completed. There will be some area for limited seating but social distancing must be maintained for those not in your "bubble".

The Club, Judges, Volunteers, Cotonfield Dog Centre and Canadian Kennel Club, accept no responsibility for any illness or injury that may arise as a result of attending these events. If you have concerns about attending, please DO NOT enter or attend. We are going to try very hard to make this a safe enjoyable event for all concerned.

Ribbons and score sheet distribution will be at the judges/stewards as to the means of delivery.

Crates are permitted inside the venue at assigned locations, however no exercise pens are permitted except for giant breeds.

Entries will be accepted in the order they are received. Payment will not be processed until after the closing date.

Move-ups are not permitted. Day of trial entries are not permitted.

Changes to Obedience Protocols

- The chair or table where the leash and other equipment is to be placed should be located at a convenient place determined by the judge but can be located in the ring or if not appropriate, just outside of the ring such that the handler can obtain the item without leaving the ring
- If a chair or table or any other surface is used to hold leashes, dumbbells, gloves or any other equipment owned by the handler, that surface must be sanitized immediately after use. Paper can be placed on the surface if sanitizing is not done but that paper must be removed immediately after use, disposed of appropriately and replaced ready for the next exhibitor
- If a re-throw of the dumbbell is required, the handler should be allowed to ask the dog to stay and the handler will go and pick up the dumbbell and return to where the dog was left. If the dog moves during this process, it will not be judged unless it is out of control
- For the article exercise in Utility, the handler can retrieve the articles to be scented from the article bag and put them on the 'article' chair.

8 REGULATIONS FOR PERFORMANCE & JUDGING

8.1.5 The judge must test each handler and dog separately (except for the Group Sit and Down exercise, where groups of dogs may be in the ring together).

8.10.1 At the conclusion of the judging of each class, judges are required to provide meaningfully marked individual scoresheets to each exhibitor. Scoresheets need not be handed out in the ring, but may be distributed to the exhibitor in any manner as decided by the individual club.

8.11.3 After all the scores for the class are recorded, the judge shall **may** call for all available dogs that have earned qualifying scores to be brought into the ring.

8.13.8 In the Novice Intermediate, Open and Utility classes, before the handler enters the ring a steward will take the they shall place the dumbbell, glove and articles on a chair in or place them where designated by the judge until required and upon completion of their routine the handler shall retrieve the dumbbell, glove and articles before exiting the ring. return them after the team exits the ring. The leash shall be placed by the handler in the same location taken from the handler as the dumbbell, glove and articles once they enter the ring. and will be returned before the handler leaves the ring. The handler shall retrieve the leash from the location designated by the judge before leaving the ring.

9 PRE-NOVICE CLASS

9.2.2 The judge will post the choice of a Group Sit or Down at least 30 minutes before the start of the class and not more than one hour before the start of the trial **in a location available for viewing by all competitors. This location may be inside or outside if the trial is held indoors.** In future assignments, judges are required to randomize their choice so that each is used approximately the same number of times.

9.6.3 In the Figure 8 exercise, the handler will stand with the dog sitting in heel position facing the judge, midway between the two stewards, who will stand **cones at least 0.46m (18") high, chairs or similar inanimate objects placed** about 3.66 m (12 ft) apart. The handler may go around either steward **object** first. On the judge's order, the handler, with the dog on a loose leash, shall go twice completely around the Figure 8 with one halt at the end of the exercise. The handler may give the dog a verbal command to sit.

9.7 Sit for Examination

9.7.4 The judge will approach the dog from the front and touch its head only. On the judge's order, the handler will return by walking around behind the dog to heel position.

9.9 Group Sit or Down Exercise

- 9.9.4 All dogs in the class that are eligible to compete in the group exercises **may be judged separately or as part of a group after the completion of the individual exercises. I there is more than one dog competing in the group exercise, the dogs must be placed at least 2.44m (8') apart. In order to accommodate the distance requirement, there may be more than one group. A dog who fails any of the individual exercises is not eligible to compete.** Will do so together. If, however there are more than eight dogs competing they will be split into groups of not more than eight.
- 9.9.5 Handlers will enter the ring with their dogs on leash and line up in a straight line in catalogue order, at least 1.22 m (4 ft) **2.44m (8 ft)** apart, where the judge indicates. Handlers will place their armbands behind the dogs. They will leave the leash attached to the dog's collar, placing it at the dog's right side.

10 NOVICE CLASS

10.6 Heel on Leash & Figure 8

10.6.8 In the Figure 8 exercise, the handler will stand with the dog sitting in heel position facing the judge, midway between the two stewards, who will stand **cones at least 0.46m (18") high, chairs or similar inanimate objects placed** about 2.44 m (8 ft) apart. The handler may go around either steward **object** first. On the judge's order, the handler with the dog on a loose leash shall go twice completely around the Figure 8 with at least one halt during and another at the end of the exercise.

10.7 Stand for Examination

10.7.3 On completion of the Figure 8 exercise, the handler will remove the leash and give place it to a steward, who will place it on the judge's table. on a chair designated by the judge. If necessary the dog may be guided gently by the collar.

10.7.5 The judge will approach the dog from the front and touch the dog's head, withers and hindquarters only. On the judge's order, the handler will return by walking around behind the dog to heel position.

10.9 Recall

10.9.7 On completion of the Recall, the handler may ask the dog to stay or may guide the dog gently by the collar in order to retrieve the leash from the chair previously designated by the judge and put it on the dog before leaving the ring.

10.10 Group Sit and Down Exercises

- 10.10.4 All dogs in the class that are eligible to compete in the group exercises **may be judged separately or as part of a group after the completion of the individual exercises. If there is more than one dog competing in the group exercise, the dogs must be placed at least 2.44m (8') apart. In order to accommodate the distance requirement, there may be more than one group. A dog who fails any of the individual exercises is not eligible to compete.** will do so together. If, however, there are more than eight dogs competing, they will be split into groups of not more than eight.
- 10.10.5 When the same judge judges the Novice A, B and/or C classes, the classes may be combined provided the total number of dogs **eligible to compete** in the group does not exceed eight **can be placed at least 2.44 m (8 ft) feet apart.**
- 10.10.6 Handlers will enter the ring with their dogs on leash and line up in catalogue order along one side of the ring **at least 2.44 m (8 ft) apart, where the judge indicates.** Handlers will place their armbands, weighted with leashes behind the dogs.

10.10.8 The judge shall take a position in the ring where both the dogs and handlers can be observed **but must be at least 2.44 m (8 ft) feet from any person.** One minute after giving the order to "Leave your dogs," the judge will order the handlers to return promptly to their dogs, each walking around behind his own dog to the heel position. The dogs should not move from the sitting position until the judge says "Exercise finished."

11. NOVICE INTERMEDIATE CLASS

11.8 Recall Over High Jump Holding the Dumbbell

11.8.4 The high jump in all classes will be set according to Rally jump heights i.e. A dog Under 25.4 cm (10 in) at withers---will jump 15.2 cm (6 in); A dog height from 25.4 cm (10 inches) and under 38 cm (15 in) will jump 20.3 cm (8 in); A dog height from 38 cm (15 in) and under 50.8 cm (20 in) will jump 30.5 cm (12 in); A dog height of 50.8 cm (20 in) and over will jump 40.6 cm (16 in) There will not be any additional accommodation made for veteran jump height given the lowered levels

11.9 Recall Over Broad Jump

11.9.2 The Broad Jump will be spaced to cover a distance equal to twice the height of the high jump

12 OPEN CLASS

12.5 Exercises and Scores for Open HB & 18B

12.5.1 For Open HB and 18 B classes, the routine to be used will be the Routine # 1 only i.e., the routine used in the A class

12.12 Change of Positions

12.12.2 In the 18B class sequence (a) will be used

12.13 Group Sit & Down Exercises

12.13.4 per recommendations in Novice Section

12.14 Group Sit – Walk Around Exercise

13. UTILITY CLASS

There will be designated area (eg. chair, small table, large box) beside/near the ring for the handler's leash, glove, and articles. It must be easily accessible by the handler and is cleaned between dogs. This area can be the same as the area as that used in the Scent Discrimination exercise. Stewards will wear gloves for activities and will use fresh gloves for each dog/handler team

13.4 Exercises and Scores for Utility B

For the Utility B class the routine used will be UTILITY 1 (the same routine used for Utility A)

13.6 Seek Back

13.6.3 The glove must be plain, dark in colour, and **visually** approved by the judge. It must be carried in the handler's right hand.

13.7 Scent Discrimination

13.7.4 The Scent Discrimination exercise consists of two separate exercises in which the dog must select an article by scent. The articles shall be provided by the handler and shall consist of three sets of five identical articles. One set will be made of wood, one of metal and one of leather. The articles may be items of everyday use. The size of the articles will be proportionate to the size of the dog. The metal articles will be of rigid metal. The articles in each set will be legibly numbered with a different number and must be **visually** approved by the judge. The judge will select two articles to be used. These two articles shall be placed conveniently within reach of the handler **using a minimal contact process determined by the judge (e.g. steward or judge using gloves or disinfected tongs or may be taken by the handler)**, and shall not be handled by anyone else. The remaining 13 articles will be placed in full view, about 6.09 m (20 ft) in front of the handler and dog, about 15.24 cm (6 inches) apart and may be handled by the steward or judge.

13.10 Directed Jumping

13.10.3 Jump heights are set as in the Retrieve over High Jump exercise according to Rally jump heights i.e.

A dog Under 25.4 cm (10 in) at withers---will jump 15.2 cm (6 in);

A dog height from 25.4 cm (10 inches) and under 38 cm (15 in) will jump 20.3 cm (8 in);

A dog height from 38 cm (15 in) and under 50.8 cm (20 in) will jump 30.5 cm (12 in);

A dog height of 50.8 cm (20 in) and over will jump 40.6 cm (16 in)

There will not be any additional accommodation made for veteran jump height given the lowered levels.

Official Obedience Novice Classes

9.1 Pre Novice

- 9.1.1 The Pre-Novice Class is an elective class and earning the title is not a requirement to enter Novice Classes.
- 9.1.2 The Pre-Novice Class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of P.C.D.
- 9.1.3 Dogs in this class may be handled by the owner or any other person.
- 9.1.4 A person may enter more than one dog in this class.
- 9.1.5 The same handler must handle each dog in all 5 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the Group Exercise.
- 9.1.6 Only dogs that have not earned the title of C.D. may enter the Pre-Novice class.

10.1 Novice A

- 10.1.1 The Novice A Class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of C.D.
- 10.1.2. Only one dog per handler is allowed in this class, and that person must handle the dog in all exercises.
- 10.1.3. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families, and must be eligible to handle under section 10.1.4.
- 10.1.4. No person who has trained or exhibited a dog that has earned a C.D.X. title shall be allowed to handle a dog in this class.
- 10.1.5 When a dog is wrongfully entered in this class, any score awarded will be cancelled.

10.2 Novice B

- 10.2.1 The Novice B Class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of C.D.
- 10.2.2. Dogs in this class may be handled by the owner or any other person.
- 10.2.3 A person may enter more than one dog in this class.
- 10.2.4 The same handler must handle each dog in all 6 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the Group Exercises.
- 10.2.5 No dog may be entered in both the Novice A and Novice B Class at any one trial.

10.3 Novice C

- 10.3.1 The Novice C Class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned the title C.D. or any higher obedience titles.
- 10.3.2 Dogs in this class may be handled by the owner or any other person.
- 10.3.3 A person may enter more than one dog in this class.
- 10.3.4 The same handler must handle each dog in all 6 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the Group Exercises.
- 10.3.5 Dogs may compete in the Novice C class indefinitely.
- 10.3.6 Scores earned by dogs entered in the Novice C Class are not eligible for High In Trial and do not qualify a dog for any title.
- 10.3.7 Dogs may be entered the Novice C Class in addition to any other official *or* unofficial classes for which they are eligible.

11.1 Novice Intermediate

- 11.1.1 The Novice Intermediate Class is an elective class and earning the title is not a requirement to enter the Open Classes.
- 11.1.2 The Novice Intermediate Class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned a C.D. or any higher obedience trial titles.
- 11.1.3 Dogs in this class may be handled by the owner or any other person.
- 11.1.4 A person may enter more than one dog in this class.
- 11.1.5 The same handler must handle each dog in all 6 exercises.
- 11.1.6 Dogs may compete in the Novice Intermediate class indefinitely.
- 11.1.7 Scores earned by dogs competing in this class are not eligible for High In Trial.
- 11.1.8 Dogs may be entered in the Novice Intermediate Class in addition to any other official or unofficial classes for which they are eligible.

Official Obedience Open Classes

12.1 Open Classes

12.1.1 There are four (4) Open classes: The Open HA and Open HB classes, which include the Out of Sight Group Stay Exercises and the Open 18A and Open 18B classes, which include the Change of Positions and Group Sit - Walk Around exercises.

12.1.2 No dog may be entered in more than one Open Class at any one trial.

12.2 Open HA and Open 18A

12.2.1 The Open A Classes shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D. but has not earned the title of C.D.X.

12.2.2 The handler of any dog in this class must be the owner or a member of their immediate families.

12.2.3 Only one dog per handler is allowed in this class and that person must handle the dog in all exercises.

12.2.4 Any person who has trained or exhibited a dog that has earned a U.D. title may not handle a dog in these classes.

12.2.5 When a dog is wrongfully entered in these classes, any score awarded will be cancelled.

12.3 Open HB & Open 18B

12.3.1 The Open B Classes shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D.

12.3.2 Dogs that have earned the title of C.D.X. or any higher obedience titles may enter either of the Open B classes. A dog may also be entered in the Utility Class in the same trial.

12.3.3 Dogs in this class may be handled by the owner or any other person.

12.3.4 A person may enter or handle more than one dog in this class.

12.3.5 The same handler must handle each dog in all 7 exercises unless he has 2 or more dogs entered. In such case, they must have an additional handler for each extra dog when they are judged together in the group exercise(s).

12.3.6 No dog may be entered in both the Open A and Open B classes at any one trial.

12.2.7 Prior to the start of judging, the judge will choose which of the six numbered routines is to be performed for Open HB and Open 18B, and which sequence of positions is to be performed in the Change of Positions exercise in the 18B class (in the Open 18A class only sequence (a) will be performed). These choices will not be disclosed to exhibitors until it is posted at ring side at least 30 minutes before the start of each class and never more than one hour before the start of the trial. In future assignments, judges are required to alternate the six routines so that each routine and sequence will be used approximately the same number of times.

Official Obedience Utility Classes

13.1 Utility Class A

13.1.1 The Utility A Class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D.X. but has not earned the title of U.D.

13.1.2 Any person who has trained or exhibited a dog that has earned a M.O.T.Ch. title may not handle dogs in this class.

13.1.3 The handler of any dog in this class must be the owner or a member of their immediate families.

13.1.4 Owners may enter more than one dog in this class. The same person must handle the dog in all exercises.

13.1.5 When a dog is wrongfully entered in this class, any score awarded will be cancelled.

13.2 Utility Class B

13.2.1 The Utility B Class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D.X. or U.D.

13.2.2 Dogs in this class may be handled by the owner or any other person.

13.2.3 Owners may enter more than one dog in this class. The same person must handle the dog in all exercises.

13.2.4 No dog may be entered in both the Utility A and Utility B classes at any one trial.

13.2.5 Prior to the start of judging, the judge will choose which of the six numbered routines will be performed.

This choice will not be disclosed to exhibitors until it is posted at ring side at least 30 minutes before the start of the class. In future assignments, judges are required to alternate the six routines so that each will be used approximately the same number of times.

Unofficial Obedience Classes

16.1 Unofficial Classes

16.1.1 All dogs entered in the Unofficial Classes must be entered in one of the Official Classes or Exhibition Only.

16.5 Wild Card Classes

16.5.1. No title is required for entry in any Wild Card class, but any dog entered must be capable of performing the exercises required at the class level in which it is entered.

16.5.2 The owner or any other person may handle dogs in these classes.

16.5.3 A person may enter more than one dog in any of these classes.

16.5.4 Handlers may use verbal encouragement and praise during exercises in these classes without penalty. Handlers may also use additional commands, but will be penalized accordingly.

16.5.5 The Wild Card option: A handler may choose to perform all exercises in a class, in which case all will be scored, or a handler may choose to skip one exercise and receive full credit for that exercise. The handler must inform the judge which exercise will be skipped before beginning the exercises. If an exercise is chosen to be skipped, it may not be performed. (E.g., a handler may choose to omit the Stand for Examination in Novice, the Long Down in Open, or the Directed Jumping in Utility, and receive a perfect score for the exercise.)

16.5.6 Wild Card Novice Class. Any dog that is capable of performing the Novice class exercises may be entered in the Wild Card Open class, which will be performed and judged as the regular Open A class.

16.5.7 Wild Card Open Class. Any dog that is capable of performing the Open Class exercises may be entered in the Wild Card Open Class, which will be performed and judged as the regular Open A Class.

16.5.8 Wild Card Utility Class. Any dog that is capable of performing the Utility Class exercises may be entered in the Wild Card Utility Class, which will be performed and judged as the regular Utility A Class. Handlers are permitted to encourage and praise their dogs verbally during the performance of all Utility exercises except the signal exercise.

16.8 Veterans Class

16.8.1 The Veterans Class shall be for any dog that has earned the title of C.D. or higher and is 7 years old or older on the day of the trial.

16.8.2 The exercises shall be performed and judged as in the Novice Classes.

16.8.3 The owner or any other person may handle a dog in this class.

16.8.4 A person may enter more than one dog in this class.

16.8.5 The same handler must handle each dog in all 6 exercises unless he has 2 or more dogs entered. In such case, he must have an additional handler for each extra dog when they are judged together in the Group Exercises.

Additional Note: For Veterans at this trial, 1 point is awarded for each year over 7 years of age in class.

CANADIAN KENNEL CLUB Non Member Participation Fee (April 2011)

- A non member participation fee will be charged to a resident of Canada who is a non-member of the CKC.
- The non member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.

Changes to Rally Protocols

- The chair or table where the leash and other equipment is to be placed should be located at a convenient place determined by the judge but can be located in the ring or if not appropriate, just outside of the ring such that the handler can obtain the item without leaving the ring
- In the Rally Advanced Class, the handler can put the leash in their pocket or hang it around the neck as in the Pre-Novice recall.
- 4.3.2 The formula for the preparation of the judging schedule shall be based on the judging of a maximum of 10 dogs per hour. A 10 –minute walk-through for each class level must be included in the scheduled judging times and walk-through's may be extended by the judge if required. (A & B classes of each level judged by the same judge may be combined for walk- throughs.) Walk through's will be limited to 5 exhibitors at a time who must observe 6' social distancing. If a large class is scheduled, judges will allow an additional 10-minute walk-through every two hours for the next block of dogs to be judged in the class.
- Score sheets and awards will placed on at table outside the ring. High in Class awards will be announced from within the ring.

Official Rally Classes

9.1 Rally Novice A

9.1.1 Dogs competing in this class may not have earned the R. N. title or any Obedience title other than P.C.D.. No handler who has exhibited a dog through its CKC C.D.X. title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class.

9.1.2 No dog may be entered in both Rally Novice A and Rally Novice B at any one trial.

9.2 Rally Novice B

9.2.1 Any dog may compete in this class until a qualifying score in the Rally Advanced Class is earned. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

10.1 Rally Intermediate

10.1.1 The Rally Intermediate Class is an elective class and earning the title is not a requirement to enter Rally Advanced Classes.

10.1.2 This class shall be for dogs that have earned the R.N. title. A dog completing the R.I. or any other obedience or rally titles may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

11.1 Rally Advanced A

11.1.1 This class shall be for dogs that have earned the R. N. title but have not earned the R. A. title or any CKC Obedience title other than P.C.D.. No handler who has exhibited a dog through its CKC C.D.X. title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class.

11.1.2 No dog may be entered in both Rally Advanced A and Rally Advanced B at any one trial.

11.2 Rally Advanced B

11.2.1 This class will be for dogs that have earned the R.N. title. A dog completing the R.A. title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

12.1 Rally Excellent A

12.1.1 This class shall be for dogs that have earned the R. A. title, but have not earned the R. E. title or any CKC Obedience title other than P.C.D.. No handler who has exhibited a dog through its CKC C.D.X. title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class.

12.1.2 No dog may be entered in both Rally Excellent A and Rally Excellent B at any one trial.

12.2 Rally Excellent B

12.2.1 This class will be for dogs that have earned the R.A. title. A dog completing the R.E. title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

13.1 Rally Master

13.1. This class will be for dogs that have earned the RE title. A dog completing the RM title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

14 Rally Advanced Excellent (RAE)

14.1 Upon completion of the Rally Excellent title, qualifying scores may be accumulated from the Rally Advanced B Class and the Rally Excellent B Class to earn the Rally Advanced Excellent (RAE) title.

14.2 In order to receive the RAE title, a dog must qualify 10 times in both the Rally Advanced B Class and the Rally Excellent B Class at the same trial. The RAE title will appear at the end of the dog's name and a numeric designation will indicate the number of times the dog has met RAE requirements, i.e. RAE2, RAE3, etc.

15 Rally Master Excellent (RMX)

15.1 Upon completion of the Rally Master title, qualifying scores may be accumulated from the Rally Excellent B Class and the Rally Master Class to earn the Rally Master Excellent (RMX) title.

15.2 In order to receive the RMX title, a dog must qualify 10 times in both the Rally Excellent B Class and the Rally Master Class at the same trial with scores of 90 or higher in Excellent and 85 or higher in Master. Double qualifying score must be earned under at least five different judges. The RMX title will appear at the end of the dog's name and a numeric designation will indicate the number of times the dog has met RMX requirements - i.e., RMX2, RMX3, etc.

Unofficial Rally Classes

15.1 Unofficial Classes

15.1.2 All dogs entered in unofficial classes must also be entered in an official Rally class or Exhibition Only.

15.2 Rally Brace Classes

15.2.1 Brace class requirements shall be the same as those listed for the Obedience Brace Class, except that they are open to any 2 dogs that have earned a title of R.N. or higher.

15.2.2 Clubs may offer one or all levels of classes: Rally Novice, Rally Advanced and/or Rally Excellent.

15.3 Rally Team Classes

15.3.1 Eligibility for Team Classes shall be the same as that listed for the Obedience Team Class, except that the class is open to any 4 dogs that have earned a title of R.N. or higher.

15.3.2 Clubs may offer one or all levels of classes: Rally Novice, Rally Advanced and/or Rally Excellent.

15.3.3 Each team member will run the course individually, with the team time running continuously. The judge will give the first member of the team the "Forward" command from the "Start" sign. Each subsequent dog and handler will start when the previous dog and handler pass the "Finish" sign, without any additional command of "Forward" by the judge. Timing for each team will begin when the judge commands "Forward" to the first handler in the team and will stop when the fourth handler and dog pass the finish line.

Junior Obedience Classes

9.1 Classes in **Junior Obedience Competition** shall be divided as follows:

(a) Junior Obedience Pre-Novice: This class is for handlers 7 years of age on the date of the competition up to the date of their 11th birthday who have not achieved 500 score points in any Pre-Novice competition.

(b) Intermediate Obedience Pre-Novice: This class is for handlers 11 of age on the date of the competition up to the date of their 15th birthday who have not achieved 500 score points in any Pre-Novice competition.

(c) Senior Obedience Pre-Novice: This class is for handlers 15 years of age on the date of the competition up to the date of their 18th birthday who have not achieved 500 points in any Pre-Novice competition.

(d) Junior Obedience Novice: This class is for handlers 7 years of age on the date of the competition up to the date of their 11th birthday who have achieved 500 score points in any Pre-Novice competition or for any junior of relevant age who wishes to compete in this class.

(e) Intermediate Obedience Novice: This class is for handlers 11 of age on the date of the competition up to the date of their 15th birthday who have achieved 500 score points in any Pre-Novice competition or for any junior of relevant age who wishes to compete in this class.

(f) Senior Obedience Novice: This class is for handlers 15 years of age on the date of the competition up to the date of their 18th birthday who have achieved 500 score points in any Pre-Novice competition or for any junior of relevant age who wishes to compete in this class.

(g) Junior Obedience Open: This class is for handlers 7 years of age on the date of the competition up to the date of their 11th birthday.

(h) Intermediate Obedience Open: This class is for handlers 11 of age on the date of the competition up to the date of their 15th birthday.

(i) Senior Obedience Open: This class is for handlers 15 years of age on the date of the competition up to the date of their 18th birthday.

6.1.6 Subject to the provisions stated in these rules, no dog may be entered in any class for which it is not eligible at the time entries for the trial close. The entry of a dog that is improperly entered in a class for which it is not eligible cannot be altered to another class after entries close except as provided in section 6.9.6.

6.9 Moving Up

~~6.9.1 A dog that is registered in the records of the CKC with an eligible number according to these rules and has fulfilled the requirements for a title in accordance with these rules may be moved to the next level of competition if the schedule permits. The transfer must be on the appropriate move-up form and submitted to the Trial Secretary by the owner or handler at least 15 minutes before the start of the class.~~

6.9.2 When move ups are permitted, clubs are exempt from the requirements of Section 4.3.4 and 4.3.5.

6.9.3 The Trial Secretary shall amend the judge's book and the marked catalogue, which is to be sent to the CKC with the requests attached to the appropriate entry forms.

6.9.4 If it is established by the CKC that a dog moved up to the next level has not completed the requirements for the lower level before moving up, then all qualifying ribbons and/or awards earned by the dog incorrectly entered shall be forfeited and cancelled by the CKC and the owner may be subject to disciplinary action.

6.9.5 In order for a dog to be eligible to move up, the dog must be individually registered with the CKC, have a Performance Event Number (PEN), or an Event Registration Number (ERN) before entries close. The addition of a CKC number after close of entries does not make the dog eligible and will result in referral to the Discipline Committee.

6.9.6 Exhibitors incorrectly entered in the A class are permitted to move the dog to the corresponding B or C class up to one hour before the start of the trial. Exhibitors incorrectly entered in the Novice B class are permitted to move the dog to the Novice C class up to one hour before the start of the trial.

6.9.7 Exhibitors entered in the Open H classes are permitted to move to the Open 18 classes and vice versa up to one hour before the start of the trial.

6.9.8 Exhibitors incorrectly entered in the Novice B class are permitted to move the dog to the Novice C class up to one hour before the start of the trial.

3.6 Indignities to a Judge

3.6.1 A judge officiating at a trial held under these rules shall not be subjected to indignities of any kind during the progress of the trial. It shall be the duty and obligation of the club holding the trial to see that this rule is effectively carried out.

6.4 Dogs Must Compete

6.4.1 Any dog entered and received at a trial must compete in all individual exercises of all classes in which it is entered, unless excused by the judge, superintendent or the Trial chair. If a dog is excused by any of these officials for biting or attempting to bite, the reason for the excusal must be recorded by the official on the relevant CKC form, a copy of the form provided to the dog's handler in the ring and the CKC, according to Appendix D.

6.5 Bitches In Season

6.5.1 Bitches in season are not permitted to compete. The judge of a trial must remove from competition any bitch in season, or any bitch which appears so attractive to males as to be a disturbing element.

6.5.2 When a bitch comes into season after entries have closed, the trial-giving club must refund the entry fee and listing fee providing the trial secretary receives, on or before the date of the trial, a veterinarian's certificate declaring that the bitch was in season within the 10 day period preceding the trial.

Additional Rules and Regulations

- 🐾 The club reserves the right to remove any person(s) from the show and the show grounds. The Show Superintendent shall have full control of these shows and trials, which are governed by CANADIAN KENNEL CLUB (CKC) rules.
- 🐾 Any person excused by the Show Superintendent or Veterinarian for any reason shall not, compete in any class for any awards for the balance of the shows, trials and or events.
- 🐾 The Trial committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident or misfortune to either dogs, exhibitors, spectators or vendors.
- 🐾 Exhibitors may be asked by the show superintendent for proof of third party liability insurance. Failure to produce may result in dismissal from the show grounds.
- 🐾 Dogs must be on the grounds 1 hour prior to the judging of their class.
- 🐾 The owner of a dog entered in these shows is entirely responsible for any error in entering his/her dog regardless of how or by whom the entry was made.
- 🐾 Exhibitors and handlers will be responsible for their dogs and equipment left at the show grounds.
- 🐾 No overnight recreational units permitted
- 🐾 If, because of civil disturbance or other acts beyond the control of the club, it is impossible to open or complete the show, there is no refund of entry.
- 🐾 Dogs must be on leash at all times on the show grounds with the exception of the obedience and/or rally rings.
- 🐾 Exhibitors are expected to maintain a clean area. Please be considerate when utilizing any facilities. No dogs are permitted in the washrooms.
- 🐾 The welfare of any children is deemed to be the responsibility of the guardian or parent. Please exercise control and restraint over your child's behaviour.
- 🐾 The club is not responsible for lost or stolen property from exhibitors or vendors/concessions. Check for lost property at the security desk. The club reserves the right to refuse an individuals entries, for just cause.
- 🐾 Delays waiting for dogs will not be possible and handlers with several breeds must arrange for alternative handlers if judging times for their dogs conflict.
- 🐾 The club reserves the right of restricting exhibitors space.
- 🐾 Fire lanes in all areas will be maintained.
- 🐾 All exhibitors must follow direction by Cotonfield Dog Centre owners.
- 🐾 Please park neatly.
